Fee Schedule 2023-2024

Registration Fee

An annual fee of CHF 950 covers the administrative cost of processing admissions, and is payable at the time of enrolment or re-enrolment. This fee is non-refundable, except in cases where the school is unable to offer a place.

Capital Development Fee for new students

A one-time fee of CHF 3'000 is applied only in a student's first year at the British School of Geneva, and is payable upon enrolment. This fee is put toward the ongoing maintenance and improvement of our learning environment.

For children arriving during the course of the academic year, the Registration Fee and Capital Development Fee are payable in full.

The following fees* include the cost of books, materials and lunchtime supervision.

Invoices for additional services including school lunches, transport, uniforms, extracurricular activities, after school care, learning support, external exam registration (for Years 9-13), and field trips are sent out termly and are payable at 30 days' notice.

Tuition fees will be charged on a termly basis for students arriving during the academic year.

Flexible Terms of Payment

A monthly payment plan is available, upon request and in agreement with the Principal, for families paying the entirety of school fees privately. Under the same conditions, a sibling discount may apply upon request to families with three or more children in school (see General Terms and Conditions for details). All fees for students sponsored by companies and international organisations are payable according to standard terms.
